## **JUDGE PHILIP J. GLENNIE**

### **LAW SCHOOL SCHOLARSHIP INFORMATION**

The Judge Philip J. Glennie Scholarship committee competitively awards law school scholarships each year. This scholarship is intended for and given to law students who have been accepted to a law school in the United States of America and who have graduated from a high school within one of the four counties of Alpena, Alcona, Montmorency, and Presque Isle. An application packet is available at the office of the Community Foundation for Northeast Michigan (CFNEM) at 111 Water Street, Alpena, Michigan and is also available online at [www.cfnem.org](http://www.cfnem.org)

The following are requirements for receiving a tuition scholarship:

1. The recipient must be a resident of the four-county area of Alcona, Alpena, Montmorency, or Presque Isle who has attended and graduated from a high school within this area.
2. The recipient must return the completed application to the CFNEM office by the first working day in April.
3. Financial need is not a requirement.
4. The law school must show final evidence of enrollment of the applicant.

Processing dates and deadlines are as follows:

- January – Application forms are available
- April 1 – Applications, transcripts, and letters of recommendation are due
- May – Applications are reviewed by the Scholarship Committee
- June – Applicants are notified of the committee decision.

Each one-year scholarship is paid directly to the college, not to the student. Law students may seek to renew their scholarship during their tenure in law school by submitting their updated application annually, together with a transcript of their prior year's grades and evidence of continued enrollment in a law school, directly from the law school. For renewal applications, a recipient will not be required to submit additional letters of reference nor writing sample. There is no guarantee of renewal, however.
